This Request for Expression of Interest follows the General Procurement Notice for this project that appeared in UNDB Development Business print edition issue number 755, 31 July 2009 of Notice No. W82838-755.

The Government of India has received a loan from the World Bank towards the cost of the Andhra Pradesh Municipal Development Project (APMDP) and intends to apply part of the proceeds of this funding to payments under the contracts for consultant services. The services include consultancies for the following consultancy assignments:

1. Management Consultants for Developing Municipal Reforms and Capacity Development Programs for The Urban Local Bodies (ULBs) for Improving Their Performance, Services and Efficiency With Special Focus for Financial Improvement of The ULBs. Each Assignment May Contain Group of 3 to 6 ULBs. There May Be 3 to 4 Contracts. The Duration Of The Consultant Services Shall Be About 6 Months.

The Commissioner and Director of Municipal Administration, MA&UD Department, Govt. of Andhra Pradesh, Hyderabad now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the service (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultant may associate to enhance their qualifications. The association may take the form of a joint venture (with joint and several liability) or of a sub-consultancy.

A consultant will be selected in accordance with the procedures set out in the World Bank's *Guidelines: Selection and employment of consultants by World Bank Borrowers, May 2004, revised October 2006.*

In accordance with paragraph 2.7 of the Guidelines for the selection and Employment of Consultants by the World Bank Borrowers, the short lists for these assignments may comprise entirely of national consultants, although foreign consultants may express interest for consideration.
